# 2023 Conference



# FEATURED COURT: COCONINO COUNTY

Not all of Arizona a is desert, and yes, we do get snow in this state! One of the places to go to find that snow is up north in Coconino County, the second largest county by area in the lower 48. It covers 18,661 square miles, or about 16.4% of Arizona's total area and attracts outdoor enthusiasts from all over. It is also larger than nine of the smallest states in the country. The county seat is Flagstaff, home of the Northern Arizona University Lumberjacks. As of the 2020 census, Coconino County was home to over 145,000 people, and nearly 30% of that population is Native American, representing the Havasupai, Navajo, Hualapai, and Hopi nations.

One of the most notable locations within Coconino County is the Grand Canyon, which is often considered one of the Wonders of the World. It was the 15<sup>th</sup> site in the United States to have been named a national park. Other must-see destinations in the area include the Lowell Observatory where the planet Pluto was first discovered, Bearizona off of historic Route 66 in Williams, the "Chocolate Falls" in the scenic Painted Desert, and nearby Meteor Crater, created over 50,000 years ago by a meteorite that was about 160 feet across. You will also find the highest point in Arizona located in the towering pines of Coconino County, Humphrey's Peak at 12,637 feet.

#### ARTICLES ON WHAT'S HAPPENING IN ARIZONA:

The recent retirement of the Honorable Kevin D. White has provided an opening on the Pinal County Superior Court. Six applicants are being considered for the position and the public is invited to provide comment. A hearing will be held by the Pinal County Commission on Trial Court Appointments on July 7, 2023, to review applications and hear comments. With another round of Bar exams scheduled for July, the Arizona Supreme Court recently announced the results of the February 2023 bar exam. With 232 applicants, 95 met the score requirement of 273 or higher for admission to the Arizona State Bar. In the continued fight against illegal and dangerous drugs, U.S. Customs and Border Protection officers seized approximately 294,200 fentanyl pills at the Nogales port of entry on Tuesday, June 13. They also located fentanyl powder and cocaine in the cargo area of the SUV.

Arizona has more than 100 inmates on death row at the Arizona State Prison complex in Florence. Today, there is one less person, though, as Barry Jones was released after having been sentenced to death in Pima County Superior Court in 1995. After considering new evidence, the Attorney General's office requested that Jones' conviction for first degree murder be vacated. In addition, Jones agreed to plead guilty to second degree murder for failing to seek or render aid for the victim and he was sentenced to 25 years, with credit for the time he had already served, causing him to be immediately released from prison.
